Chair welcomed everyone to an in-person meeting.

The **MK Youth Cabinet** visited as a focus group to the park on Tuesday 29 June and attended the PLUG to provide their feedback on the park for consideration;

- Young people provided a local and non-local perspective
- Consider a path around park to take pedestrians off the 'road'
- Diversity of play areas is good
- Consider app to find trails, scavenger hunt
- Park is environmentally friendly
- Lack of maps around the park

- Clear the trail towards bird hide it does not feel safe
- Refurbish bird hyde
- Sand pit area could also have something for older young people, such as a shelter
- Sand pit area could use some buckets
- Outdoor gym equipment good, but location next to café poor. It could be quite intimidating for people wanting to use the equipment
- Carbon neutral how carbon neutral are the café and caravans?
- Sensory area is hidden and could do with expansion
- Possible fund raiser for the park inflatable event on water?
- Olney duck race/riverside festival expand beyond the local
- Big banner at entrance different languages
- YCab video how to make a den Could this be encouraged at Emberton?
- YCAB Emberton Country Park should contact Community Trees:MK

- 3. **Trees and Emberton**. Information session and written report provided by arboricultural officer. See attached. Some comments/considerations to explore;
 - After trees taken down, what happens to wood branches chipped and used for mulch.
 - Replacement of trees after they are removed look at replanting.
 - Applying for grants from Forestry Commission. Right tree, right place.
 - Possible chainsaw sculpture competition
 - Only partly fell poplars/trees, use remaining tree to sculpt totem poles in situ.

5. Operational update

- The new payment entry system is working well but is a little slower than had been hoped
- Park ranger left, and new person has now joined the park as a temporary park ranger
- Camping bookings will move to a centralised function with MKC Customer Services to free up park staff to physically manage the park more. Go live date 6 July 2021
- Security contract arrangements Meeting took place. Better communication and reporting
 to be put in place. All park users encouraged to call 101 if non- emergency or 999 for
 emergencies. Security staff will cover whole park but will give greater attention to hot spot
 areas; statics and camping
- Large metal container cleared and removed from car park
- Management plan making progress

6. Updates from park stakeholders

Statics - Welcomed the new static representatives. They gave a little update on recent static meeting with park staff – leading to review of waste, communications, security and more. Regular meetings have been put in place.

Issue with Elsans – to be addressed directly with gatehouse staff and not through PLUG.

Café – Very low take up of litter pick kits. Promote more via ECP Facebook page and all PLUG members encouraged to support litter pick kits and/or to promote it.

Cafe interested in YCab/Duke of Edinburgh awards locally. **Action: share contact details between. Complete**

Sailing Club – Still processing through insurance and repairs following flood at Christmas. Electricity supply – they wish to proceed to upgrade to three phase enhanced supply from front of Emberton. Request to raise with Facilities. **Action: Liaise with Facilities**

Anglers Association – Would welcome sight of the aquatic survey results in September with a view to the lakes being stocked appropriately with fish.
