<p>Following the receipt of the independent examiner's report on the Stony Stratford Neighbourhood Plan (SSNP), Milton Keynes Council carried out a further consultation on a number of proposed additional changes to the plan from 21 November 2017 to 17 January 2018.</p> <p>4 responses were received during the consultation period and these are summarised in the attached consultation report, together with MKC's response to the points they raise. Having considered the responses, Milton Keynes Council does not consider that a further examination into the matters they raise is required.</p> <p>It is therefore recommended that the proposed additional changes that were the subject of the consultation be made to the SSNP and that the plan proceeds to a Referendum, to be held on 3 May, 2018, to coincide with the local elections.</p>
