

COUNCIL TAX APPLICATION: IMPRISONED OR DETAINED

In specific situations, a person who is imprisoned or detained may be excluded from the calculation of the number of adult residents at a property. If there is only one adult resident, or the count reduces to one or zero after accounting for disregarded individuals, a Council Tax discount may be applicable. However, individuals serving sentences for non-payment of fines or non-payment of Council Tax will not be disregarded.
