Sarah Ashmead is the ARO responsible for running the elections in the remaining 5 Buckinghamshire constituencies, and the ERO for the whole of Buckinghamshire Council.



### Registration Update

Since the election was called on Wednesday 23 May we have had:

- Around 10k new applications to register to vote (some duplicates)
- Absent Votes:
  - 3,337 new postal vote applications
  - 430 proxies
- Overseas Electors -
  - 325 new applications
  - 755 in total (30% do not have an absent vote)
- Voter Authority Certificates 117 new applications

Milton Keynes Central: £17,662.08 Milton Keynes North: £19,631.96



#### Reminders As agent, you are responsible for:

- Spending and donations following rules about how much can be spent, who donations can be accepted from, and financial reporting after the election.
- The campaign and following electoral law, including:
  - Imprints on <u>printed</u> and <u>digital</u> material
  - The <u>handling of postal votes</u>
  - Other rules such as <u>false statements about candidates or paying</u> <u>campaigners</u>

#### Reminders

#### **Voter ID**



Acceptable photographic ID required before voting in a polling station:

- Passport
- Driving licence (including provisional license)
- Blue badge
- Certain concessionary travel cards
- Identity card with PASS mark (includes the <u>All in 1 MK card</u>)
- Biometric Immigration document
- Defence identity card
- Certain national identity cards
- Expired documents can still be used, provided the photo remains a good likeness
- Those without ID can apply for a free Voter Authority Certificate until
   5pm on 26 June
- Electors may request a private area for their ID to be inspected
- A voter can return if they do not have ID, or their ID is not accepted

#### Reminders



#### Postal vote handling

- Limits on handing in postal votes at polling stations / civic offices no more than 5 can be handed in (plus your / their own).
- A postal vote returned by hand that is not accompanied by a postal vote return form will be rejected. Only 4 were rejected in May 2024.
- Political campaigners also subject to additional restriction: (can only hand in postal votes for close relative or for someone whom they provide regular care).
- No longer possible to 'drop off' postal votes at Civic (security or letter box).
- Secrecy requirements which apply at a polling station are being extended to postal and proxy votes - offence to try to find out how someone has voted on their PV.
- Only Polling Stations (day of poll) and Civic are designated for receipt by relevant officers, from 24 June – 4 July (Monday – Friday 9am – 5pm and [7am - 10pm on polling day]).

### Postal Vote Opening

#### Where and when

- Chamber at Civic Offices Sessions will commence at 2pm & 6.30pm on Monday 24 June and run every weekday (except the evening session on Friday 28 June) to the 3 July.
- From **2pm** Envelope Bs will be opened and sent for scanning. Scanning will be **continuous from 2pm**.
- From 6.30pm Envelope As will be opened.
- Marshall Arena (Balcony 2) Final sessions will be at the count venue on the 4 July

#### Who can attend?

- Candidate, Election Agent and two Postal Vote Agents per session (agent must be notified before session commences) by e-mailing Roz Tidman

#### What else...?

- Similar layout to May counters on the inside of cordon in the middle of the chamber and observers on the outside.
- DRO adjudication of provisionally rejected signatures at **1pm** on the day of every opening session except the first day and polling day.

### Postal Vote Opening

#### Access

It is important that you can follow the process and see what is happening, but secrecy is important:

- Ballot papers will be handled face down
- The practice of 'tallying' at postal vote opening sessions is prohibited
- You will not be able to lean over tables but able to observe the full process
- You should allow space for staff to work and not attempt to look at ballot paper numbers

#### **EC** Guidance

Anyone attending an opening session must not attempt to see how individual ballot papers have been marked. It follows therefore that keeping a tally of how ballot papers have been marked is not allowed.

...anyone attending a postal vote opening must not attempt to look at identifying marks or numbers on ballot papers, disclose how any particular ballot paper has been marked or pass on any such information gained from the session. Anyone found guilty of breaching these requirements can face an unlimited fine, or may be imprisoned for up to six months.

### **Polling Stations**

- No changes to polling stations used in May local and PCC elections.
- Buckingham & Bletchley 68 stations
  - 43 in Bucks area, 108 polling staff with 3 triple stations (Buckingham Community Centre, Buckingham Youth Centre, Winslow Public Hall)
  - 1 portacabin in Bletchley outside Cold Harbour School as in May 2024
- Milton Keynes Central 54 stations
- Milton Keynes North 55 stations
  - 2 portacabins at Redhouse Park and Selkirk Drive as in May 2024
- One ballot box for all ballot papers (some will have 2 because of volumes).
- Polling station staff:
  - Additional 100 poll clerks from May staffing levels for additional demand
  - All staff do online training provided by the Association of Electoral Administrators
  - Presiding officers have mandatory f2f briefing incl dealing with queues, PV handling rules and voter ID
  - We will be using greeters outside stations and 'Q' cards for any queues at 10pm
- Polling agents / candidates may ask about how many ballot papers have been issued (but our priority will be voters)
- Polling agents any not ask for information about voter ID, or postal vote returns

#### Polling Stations

#### **Campaigning outside polling stations:**

- You are not allowed to put your messages to voters, inside the polling station or the polling place (the polling place includes the entirety of the building, its grounds, and the car park).
- Cars should not be left in Polling Station car parks with campaign messages.
- You can campaign in public spaces near to polling stations but should be careful, however, to ensure that your approach is proportionate and should recognise that groups of supporters may be perceived as intimidating by voters.

#### **Tellers**

- One per candidate at any one time
- Keep access to polling places and the pavements around polling places clear to allow voters to enter
- Tellers will not be given access to the inside of a polling station unless to cast their own vote or act as a companion for a disabled voter
- Not allowed to ask to see voters ID or check if they have it
- They may remind them Voter Id is required as they approach a polling station
- Clearer signs displayed outside with Tellers do's & don'ts

## Polling day

- Polling stations open from 7am to 10pm.
- Office open 6am to 10pm for queries or problems relating to the administration of the election.
- Voters in the polling station or in a queue outside the polling station at 10 pm can apply for a ballot paper, or hand in a postal vote.

## Polling day

- Postal votes can be handed in on polling day UNTIL
   10 pm by filling a form as discussed earlier at:
  - Any polling stations within the three constituencies (Buckingham & Bletchley, Milton Keynes North, or Milton Keynes South)
  - Milton Keynes City Council, Civic Offices, 1 Saxon Gate East, Central Milton Keynes, MK9 3EJ
- Postal votes for Buckingham & Bletchley cannot be handed in at Bucks Council offices in Aylesbury

## Counting of votes

#### The venue

- The verification for all three constituencies will commence at 10pm at Marshall Arena, Stadium MK, Stadium Way, Bletchley, Milton Keynes, MK1 1ST, starting with Postal Vote Ballot Boxes.
- Parking in S1 has been paid for by MKCC Please consider car sharing.
- Access to the venue from 9.15pm via lobby door 6a (same as May).
- Photo ID required to access venue please avoid large bags and coats.

#### **Attendees**

- Candidates, election agents, and counting agents appointed by the candidate are entitled to attend.
- 16 x Counting Agents per constituency (2 per table as 8 tables in each constituency)
- 2 guests per candidate permitted by ARO no powers and can only observe constituency where candidate is standing.
- Those not on the list will leave disappointed there will be no exceptions

# The Count Venue

#### Layout

- 3 separate areas for each constituency & 3 Deputy AROs for each
- Dedicated area for the press balcony 1
- Postal vote opening at the venue balcony 2
- Dedicated area for doubtful ballot adjudication sharing provisional results
- All announcements will made from main hall and will be audible throughout the venue
- Usual wayfinding signage to help you navigate the venue
- Please stay within your assigned constituencies to avoid overcrowding at tables
- Dedicated area / Bar 3 for candidates, guests and agents
  - Water, tea / coffee, light refreshments e.g. pastries
  - TVs showing election coverage from SKY and BBC News



### **Verification The Process** & Count process

- Each constituency has 8 mini count tables, with a team leader and 8 counters. Dedicated Deputy ARO (ballot boxes colour coded by constituency).
- When you arrive, Postal Vote ballot boxes will be behind each constituency table
- Welcome announcements, then verification of Postal ballot boxes from 10pm sharp.
- Then verification of Polling station boxes as they arrive not allocated by ward, but by distance from venue:
  - 119 Polling station Ballot boxes will come directly to the Arena.
  - 2 satellite sites in Buckingham and Newport Pagnell will bring remaining 58.



### Short speeches are permitted after the results are announced



## Verification & Count process

#### **Specifics**

- Usual counting method (finger stools and flicking corners).
- When sorting between candidates, will use the coloured party markers on front tables.
- Supervisors bundle flick at front table before placing on rear table.
- Coloured trays for rear tables with 500 markers ballot papers will remain with mini count table.

#### Doubtful Ballot Papers

- As usual, supervisors will reinsert obvious papers into the count
- Adjudication will be undertaken in only one area, announcement with 2minute warning
- Once adjudicated 'for' a slip will be stapled to the ballot paper

#### Recount threshold

 Decision on the day, but: <500 is likely full recount and <750 additional bundle flick

- We have met with TVP extra funding from government to help police these elections locally
- Bucks Operational SPOC will continue to manage any issues for the Buckingham area of Buckingham & Bletchley.
  - Jodie Duggan P6015 jodie.duggan@thamesvalley.police.uk
- Count Security Hourly visits by Police to show a real security presence – option for them to remain in the count.
- MKCC Malpractice & Operational SPOC will continue to manage the risks and issues in the geographical area of Milton Keynes
  - Catherine Storey P1533 in charge of polling day resourcing / operations
  - At least 100 of the 134 polling stations to be visited high electorate stations targeted
  - Dedicated reference number for Presiding Officer to report incidents
  - 2 Dedicated double crews in MK
