# MILTON KEYNES CITY COUNCIL) (MANOR ROAD CEMETARY CAR PARK, BLETCHLEY) (OFF-STREET LIMITED WAITING PARKING PLACE) ORDER 2023) VARIATION ORDER 2024

Milton Keynes City Council ("the Council") in exercise of its powers under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

# <u> PART 1</u>

### **IMPLEMENTATION, CITATION AND DEFINITIONS**

- This Order shall come into operation on the day of 2024 and may be cited as "Milton Keynes City Council (Milton Keynes City Council (Manor Road Cemetery Car Park, Bletchley) (Off-Street Limited Waiting Parking Place) Order 2023) Variation Order 2024".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plans annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules which shall prevail.
- 4. The plans annexed to this Order are Hereby annexed to Milton Keynes City Council (Manor Road Cemetery Car Park, Bletchley) (Off-Street Limited Waiting Parking Place) Order 2023 and form part of the Order.

# <u> PART 2</u>

### VARIATIONS

- 5. Milton Keynes City Council (Manor Road Cemetery Car Park, Bletchley) (Off-Street Limited Waiting Parking Place) Order 2023 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. Article 5(2) in Part 2 of the Principal Order is replaced by the following:
  - 5. (2) Nothing in paragraph (1) of this Article shall apply so as to permit a trailer, whether or not attached to a vehicle, to park at any time in the limited waiting parking place specified in Schedule 1 to this Order.
- 7. Article 17 in Part 3 of the Principal Order is replaced by the following:

- 17. No person shall except with the permission or under the direction of a police officer in uniform, a traffic warden or a civil enforcement officer, cause or permit any vehicle to wait the limited waiting parking place specified in Schedule 1 hereto at any time:
  - (1) for a longer period than 2 hours; or
  - (2) if a period less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same parking place in the same length of road.

A vehicle which is present in the limited waiting parking place specified in Schedule 1 hereto at the commencement of the hours of operation of any restrictions imposed by this Order shall be deemed to have been left in that parking place in that length of road at the commencement of that period of operation of the restriction in question.

8. The title of Schedule 1 of the Principal Order is replaced by the following: Order:

# SCHEDULE 1

### **OFF-STREET LIMITED WAITING PARKING PLACE**

#### 24 HOURS OF EVERY DAY FOR A MAXIMUM PERIOD OF 2 HOURS RETURN PROHIBITED WITHIN 1 HOUR

#### EXCEPT WITHIN THE MARKED BICYCLE/MOTOR CYCLE AND DISABLED PERSONS' PARKING BAYS
