MILTON KEYNES CITY COUNCIL

(ELMSWELL ROAD, WAVENDON) (PROHIBITION OF ENTRY) ORDER 2025

WHEREAS the Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984, (the Act of 1984) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1 COMMENCEMENT, CITATION AND DEFINITIONS

- This Order may be cited as The Council of the Borough of Milton Keynes (Wolverton Road, Wolverton) (Prohibition of Entry) Order 2025 and shall come into operation on the day of 2025
- 2. In this Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:
 - "Bus" means a motor vehicle constructed or adapted to carry more than eight passengers (exclusive of driver);
 - "pedal cycle" has the same meaning as in Section 3 of the Pedal Cycles (Construction and Use) Regulations 1983
- 3. The plan annexed to this Order identifies the area of road described in Schedule 1 to this Order, provided that where there is any inconsistency between the plan and that Schedule, it is the wording of the Schedule which shall prevail.

PART 2 PROHIBITION OF ENTRY EXCEPT BUSES AND PEDAL CYCLES

4. No person shall, except upon the direction or with the permission of a police officer, a traffic warden, a parking attendant or Civil Enforcement Officer, cause or permit any vehicle, except buses and pedal cycles to enter the road specified in Column 1 of Schedule 1 to this Order from the road specified in Column 2 of the said Schedule.


