MILTON KEYNES CITY COUNCIL (HAVERSHAM CUM LITTLE LINFORD FOOTPATH 50) MODIFICATION ORDER 2025

This Order is made by Milton Keynes City Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Milton Keynes City Council Definitive map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely, the discovery by the authority of evidence which, when considered with all other relevant evidence available to them, shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Milton Keynes City Council hereby order that:

1. For the purposes of this Order the relevant date is 22 November 2024
2. The Milton Keynes City Council Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the *Milton Keynes City Council (Haversham cum Little Linford Footpath 50) Modification Order 2025*.

SCHEDULE

The points specified below relate to the map attached to this Order and their positions are identified by national Ordnance Survey grid references.

PART I Modification of the Milton Keynes City Council Definitive Map

DESCRIPTION OF PATH TO BE ADDED

The proposed diversion shall be A-B-C, as shown by a bold black dashed line on the enclosed map. The route will travel from point A (OS Grid Reference SP81661 42720) in a west north westerly direction for approximately 10 metres to point B (OS Grid Reference SP81652 42724), then in a generally north north easterly direction for approximately 267 metres to point C (OS Grid Reference SP 81685 42986).

The route will have a width of 1.5 metres throughout.

The above described right of way is to have the status of footpath and to be known as Haversham cum Little Linford Footpath 50.

VARIATION OF PARTICULARS OF PATH OR WAY

A new statement shall be recorded as follows:

Haversham cum Little Linford Public Footpath 50

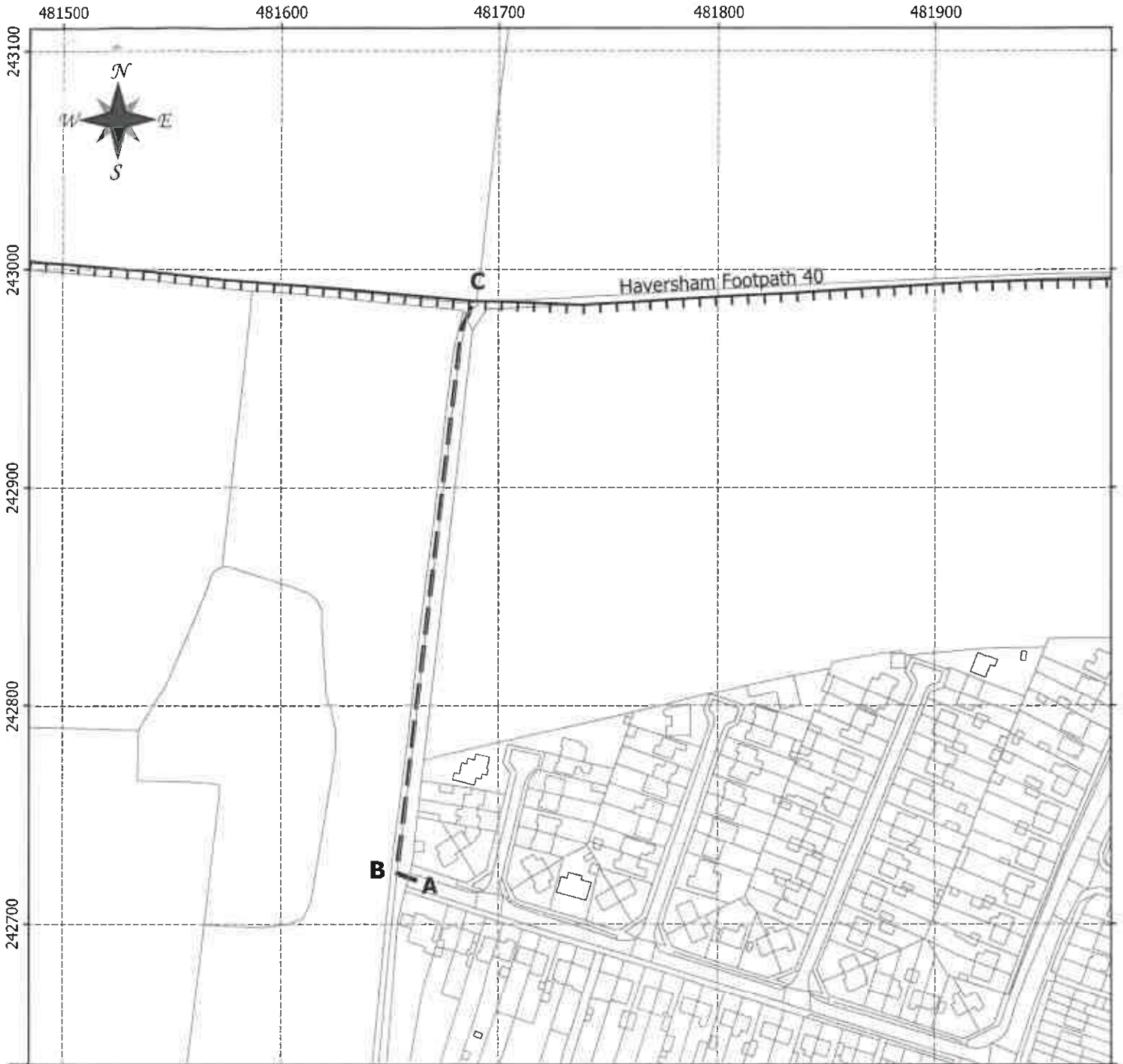
