

## **GUIDANCE NOTE 2**

#### **RESPONSIBLE AUTHORITIES**

Applications for the following must be sent to what are termed 'responsible authorities':

new premise licences / new club certificates variations to premise licences / club certificates applications for provisional statements

For most premises these will include those listed below, and applicants will need to arrange copies of their application to be given to each one on the same day that they submit their application to the Licensing Authority.

Confirmation of this will be expected.

On the rare occasions when an application involves a waterway (e.g. a licence to sell alcohol on a boat) or where the application involves land on the boundary of two Local Authorities, there are further Responsible Authorities to contact. Please contact us for details in such cases.

As the Licensing Authority will not process incomplete applications we would encourage you to check with us on the content of your application if you have any doubt as to the requirements before formally submitting it and committing to the expense of advertisements, and copies etc.

This will save unnecessary expense and time in the long run for the applicant, your agent(s) and the Licensing Authority.
