

# **MILTON KEYNES CITY COUNCIL**

## **(THE COUNCIL OF THE BOROUGH OF MILTON KEYNES) (CENTRAL MILTON KEYNES) (ON-STREET PREMIUM TARIFF PARKING PLACES) ORDER 2020) VARIATION ORDER 2025**

Milton Keynes City Council (“the Council”) in exercise of its powers under sections 1(1), 2(1) and (2), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

### **PART 1**

#### **IMPLEMENTATION AND CIATATION**

1. This Order shall come into operation on the     day of     2025 and may be cited as “Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Premium Tariff Parking Places) Order 2020) Variation Order 2025”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereunto are hereby revoked or varied to the extent stated in that Schedule.

### **PART 2**

#### **VARIATIONS**

4. The Council of Borough of Milton Keynes (Central Milton Keynes) (On-Street Premium Tariff Parking Places) Consolidation Order 2020 (“The Principal Order”) is varied as provided by the following provisions of this Order:
  - 4.1) The following definition is inserted into Part 1 of the Principal Order:  
  
**“Virtual E1 Parking Permit”**
  - 4.2) The following definitions are removed from Part 1 of the the Principal Order:  
  
“Car Share”  
“Conference Centre”  
“Hybrid Petroleum Electric Vehicle”

“Low Emission Vehicle”

“Ultra-Low Emissions Vehicle”

“Virtual Car Share Parking Permit”

“Virtual Employee Parking Permit”

“Virtual Hotel Guest and Conference Parking Permit”

“Virtual Low Emissions Parking Permit”

“Virtual Ultra-Low Emissions Parking Permit”

- 4.2) Article 7(2) (a) in Part 2 of the Principal Order is replaced with the following:

from Monday to Friday during the hours of 7.00 am and 6.00 pm by any vehicle which has either paid the relevant charge at a payment machine or by the mobile phone parking system or has been issued with a valid Virtual E1 Parking Permit.

- 4.3) Article 7(3) in Part 2 of the Principal Order is revoked in its entirety.

- 4.4) Article 8(6)b in Part 2 of the Principal Order is replaced with the following:

Has been issued with a valid Virtual E1 Parking Permit.

- 4.5) Article 8(6)c in Part 2 of the Principal Order is revoked in its entirety.

- 4.6) Article 8(6)d in Part 2 of the Principal Order is revoked in its entirety.

- 4.7) Article 8(6)e in Part 2 of the Principal Order is revoked in its entirety.

- 4.8) Article 8(6)f in Part 2 of the Principal Order is revoked in its entirety.

- 4.9) Article 8(7)b in Part 2 of the Principal Order is revoked in its entirety.

- 4.10) Article 9(1) in Part 2 of the Principal Order is replaced with the following:

Any vehicle that has been issued with a Virtual E1 Parking Permit may be left in any parking place specified in Schedule 2 of this Order, during the prescribed hours, subject to the provisions of Part 5 to this Order.

- 4.11) Article 9(2) in Part 2 of the Principal Order is revoked in its entirety.

- 4.12) Article 9(3) in Part 2 of the Principal Order is revoked in its entirety.

- 4.13) Article 9(4) in Part 2 of the Principal Order is revoked in its entirety.

- 4.14) Article 9(5) in Part 2 of the Principal Order is revoked in its entirety.

- 4.15) The title of Part 5 in the Principal Order is replaced by the following:

**PART 5**

**PROVISIONS FOR VIRTUAL E1 PARKING PERMITS**

- 4.16) All reference to “Employee Parking Permit” in all Articles within Part 5 of the Principal Order is replaced by “E1 Parking Permit”.

- 4.17) Article 40 in Part 5 of the Principal Order is replaced by the following:

40. (1) Any business located within Central Milton Keynes may apply to the Council for the issue of a Virtual E1 Parking Permit for use by each of their employees who is the user of a motor vehicle or electric vehicle other than a person whom such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

40. (2) Any person who is employed by a business located within Central Milton Keynes as an employee working regular hours and who is the user of a motor vehicle or electric vehicle may apply to the Council for the issue of a Virtual E1 Parking Permit for use by the employee of such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

- 4.18) Article 41 in Part 5 of the Principal Order is replaced by the following:

Any person who resides in a property located within Central Milton Keynes as a resident and who is the user of a motor vehicle or electric vehicle may apply to the Council for the issue of a Virtual E1 Parking Permit for use by the resident of such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

- 4.19) Part 6 of the Principal Order is removed in its entirety.

- 4.20) Part 7 of the Principal Order is removed in its entirety.

- 4.21) Part 8 of the Principal Order is removed in its entirety.

- 4.22) Part 9 of the Principal Order is removed in its entirety.

4.23) Part 11 of the Principal Order is replaced by the following:

PD133 Its entire length.

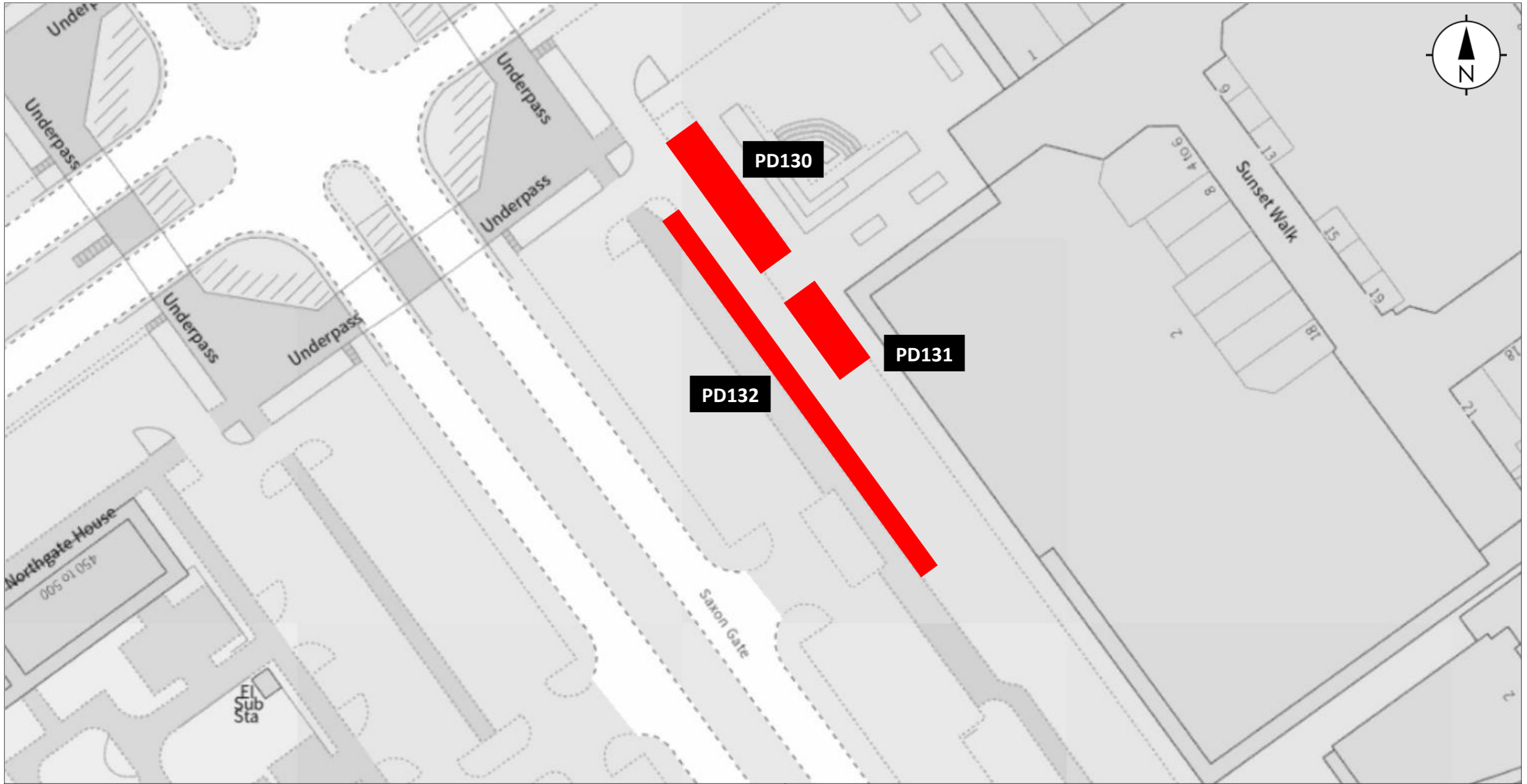

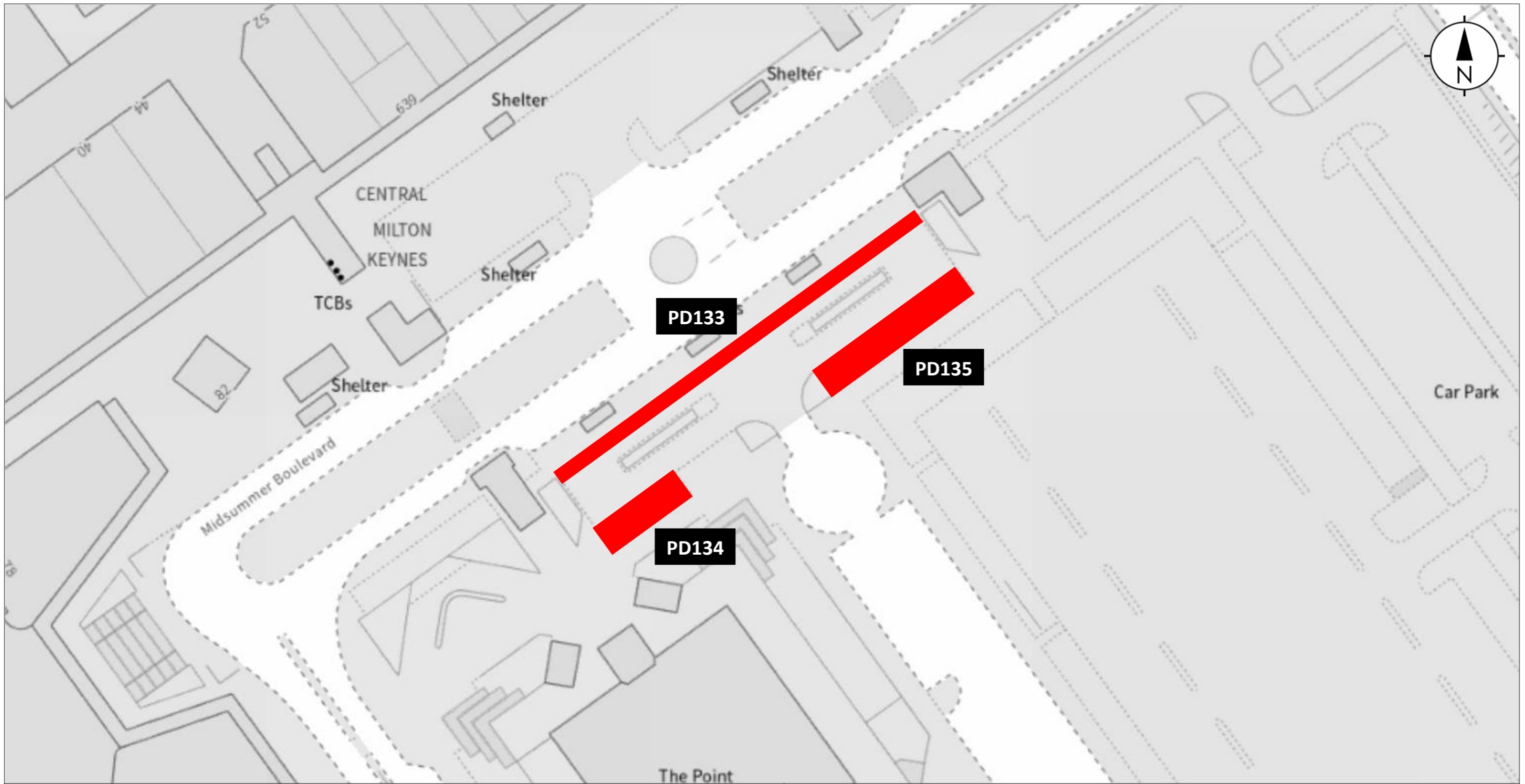
