

MILTON KEYNES CITY COUNCIL

(THE COUNCIL OF THE BOROUGH OF MILTON KEYNES) (CENTRAL MILTON KEYNES) (ON-STREET STANDARD TARIFF PARKING PLACES) ORDER 2020) VARIATION ORDER 2025

Milton Keynes City Council (“the Council”) in exercise of its powers under sections 1(1), 2(1) and (2), 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the day of 2025 and may be cited as “Milton Keynes City Council (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Standard Tariff Parking Places) Order 2020) Variation Order 2025”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereunto are hereby revoked or varied to the extent stated in that Schedule.

PART 2

VARIATIONS

4. The Council of Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Tariff Parking Places) Consolidation Order 2020 (“The Principal Order”) is varied as provided by the following provisions of this Order:
 - 4.1) The following definition is inserted into Part 1 of the Principal Order:
“Virtual E1 Parking Permit”

“Car Share”
“Conference Centre”

- 4.3) The word “Employee” in Articles 7(1) to 7(6) in Part 2 of the Principal Order is replaced with “E1”.
- 4.4) All reference to “Car Share” is removed in its entirety from Articles 7(1) to 7(6) in Part 2 of the Principal Order.
- 4.5) All reference to “Hotel and Conference” is removed in its entirety from Articles 7(1) to 7(6) in Part 2 of the Principal Order.
- 4.6) All reference to “Low Emissions” is removed in its entirety from Articles 7(1) to 7(6) in Part 2 of the Principal Order.
- 4.7) All reference to “Ultra-Low Emissions” is removed in its entirety from Articles 7(1) to 7(6) in Part 2 of the Principal Order.
- 4.8) Article 8(4)b in Part 2 of the Principal Order is replaced with the following:
has been issued with a valid virtual E1 Parking Permit.
- 4.9) Articles 8(4)c, 8(4)d, 8(4)e and 8(4)f in Part 2 of the Principal Order are removed in their entirety.
- 4.10) Any reference to Employee in Article 9(1) in Part 2 of the Principal Order is replaced with E1.
- 4.11) Articles 9(2), 9(3), 9(4) and 9(5) in Part 2 of the Principal Order are removed in their entirety.
- 4.12) The title of Part 5 in the Principal Order is replaced by the following:

PART 5

PROVISIONS FOR VIRTUAL E1 PARKING PERMITS

- 4.13) All reference to “Employee Parking Permit” in all Articles within Part 5 of the Principal Order is replaced by “E1 Parking Permit”.
- 4.14) Article 40 in Part 5 of the Principal Order is replaced by the following

40. (1) Any business located within Central Milton Keynes may apply to the Council for the issue of a Virtual E1 Parking Permit for use by each of their employees who is the user of a motor vehicle or electric vehicle other than a person whom such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

40. (2) Any person who is employed by a business located within Central Milton Keynes as an employee working regular hours and who is the user of a motor vehicle or electric vehicle may apply to the Council for the issue of a Virtual E1 Parking Permit for use by the employee of such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

4.15) Article 41 in Part 5 of the Principal Order is replaced by the following:

Any person who resides in a property located within Central Milton Keynes as a resident and who is the user of a motor vehicle or electric vehicle may apply to the Council for the issue of a Virtual E1 Parking Permit for use by the resident of such vehicle has been let for hire or reward for the leaving of the said vehicle, to park in a parking place specified in Schedule 2 of this Order, during the prescribed hours.

4.16) Part 6 of the Principal Order is removed in its entirety.

4.17) Part 7 of the Principal Order is removed in its entirety.

4.18) Part 8 of the Principal Order is removed in its entirety.

4.19) Part 9 of the Principal Order is removed in its entirety.

4.20) Part 14 of the Principal Order is replaced by the following:

PS376 From a point 14.7 metres south-west of the south-western side of the porte cochre (leading to Field Walk in Centre:mk), for a distance of 16 metres in a south-westerly direction.

MIDSUMMER BOULEVARD, CENTRAL MILTON KEYNES

PS380 From the north-eastern side of the porte cochre (leading to Field Walk in Centre:mk), for a distance of 17.1 metres in a north-easterly direction.

PS381 From a point 53.1 metres north-east of the north-eastern side of the porte cochre (leading to Field Walk), continuing in a north-easterly direction to the south-western side of the porte cochere (leading to Gold Old Walk in Centre:mk).

PS382 From the north-eastern side of the porte cochre (leading to Gold Old Walk in Centre:mk), continuing in a north-easterly direction to the south-western kerblines of the access road leading to Midsummer Boulevard.

AVEBURY BOULEVARD, CENTRAL MILTON KEYNES

THE NORTH-WEST VEHICULAR ACCESSWAY – NORTH-WEST SIDE

PS383 From a point 8.8 metres north-east of a point in line with the centreline of the access road leading to Avebury Boulevard (south-west of Lower Twelfth Street, for a distance of 39 metres in a north-easterly direction.

AVEBURY BOULEVARD, CENTRAL MILTON KEYNES

THE NORTH-WEST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

PS384 From Lower Twelfth Street to the north-eastern side of the porte cochere situated south-west of Lower Twelfth Street.

SECKLOW GATE, CENTRAL MILTON KEYNES

THE NORTH-EAST VEHICULAR ACCESSWAY – NORTH-EAST SIDE

PS385 From the south-east side of the south-eastern vehicular accessway of Avebury Boulevard, continuing in a south-easterly direction to the access road leading to the Xscape car park.

SECKLOW GATE, CENTRAL MILTON KEYNES

THE NORTH-EAST VEHICULAR ACCESSWAY – SOUTH-WEST SIDE

PS386 From the north-west side of the access road leading to Secklow Gate (between Avebury Boulevard and Childs Way), for a distance of 41 metres in a north-westerly direction.

PS387 From the north-west side of the access road leading to Secklow Gate (between Avebury Boulevard and Childs Way), for a distance of 73.5 metres in a north-westerly direction.

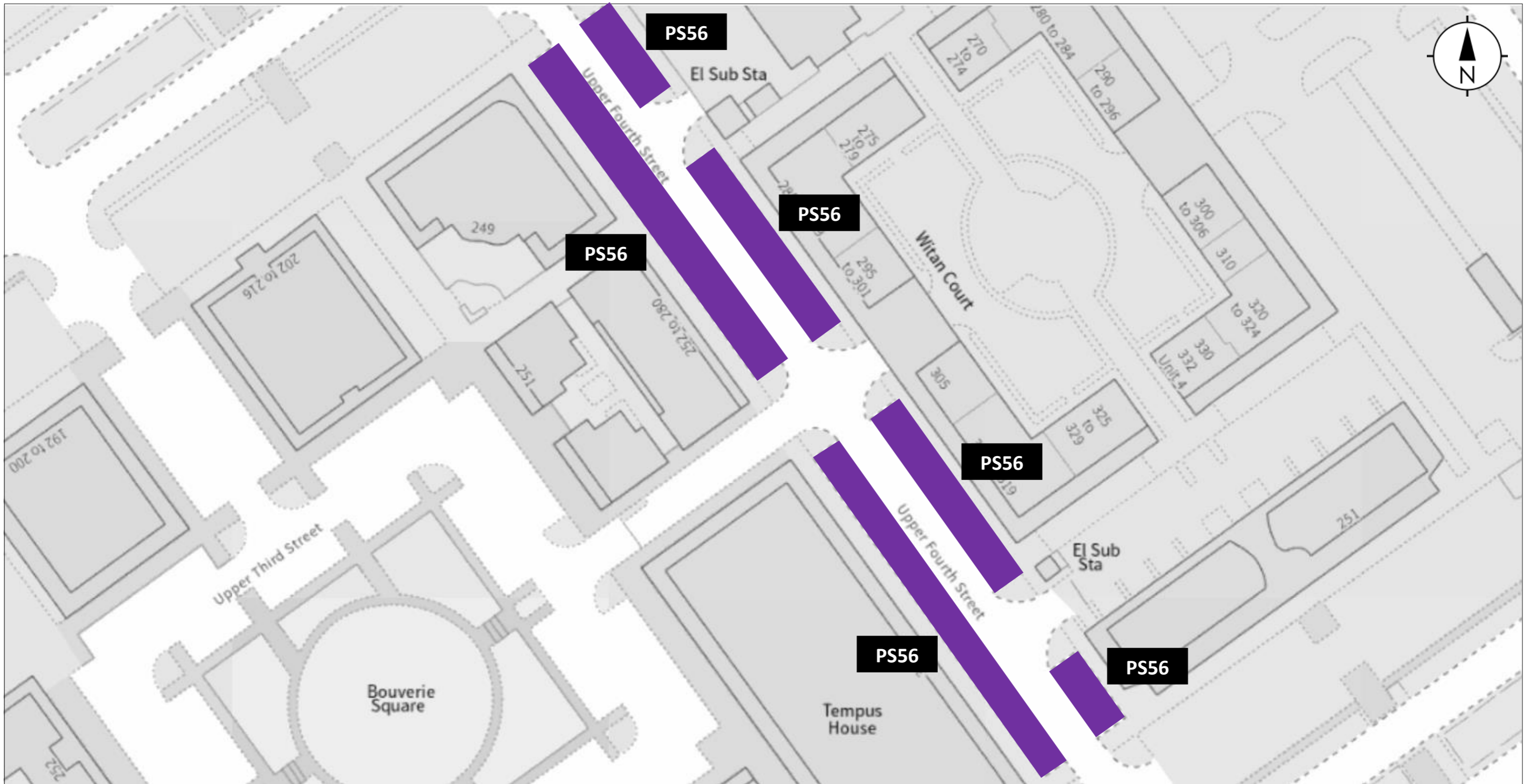

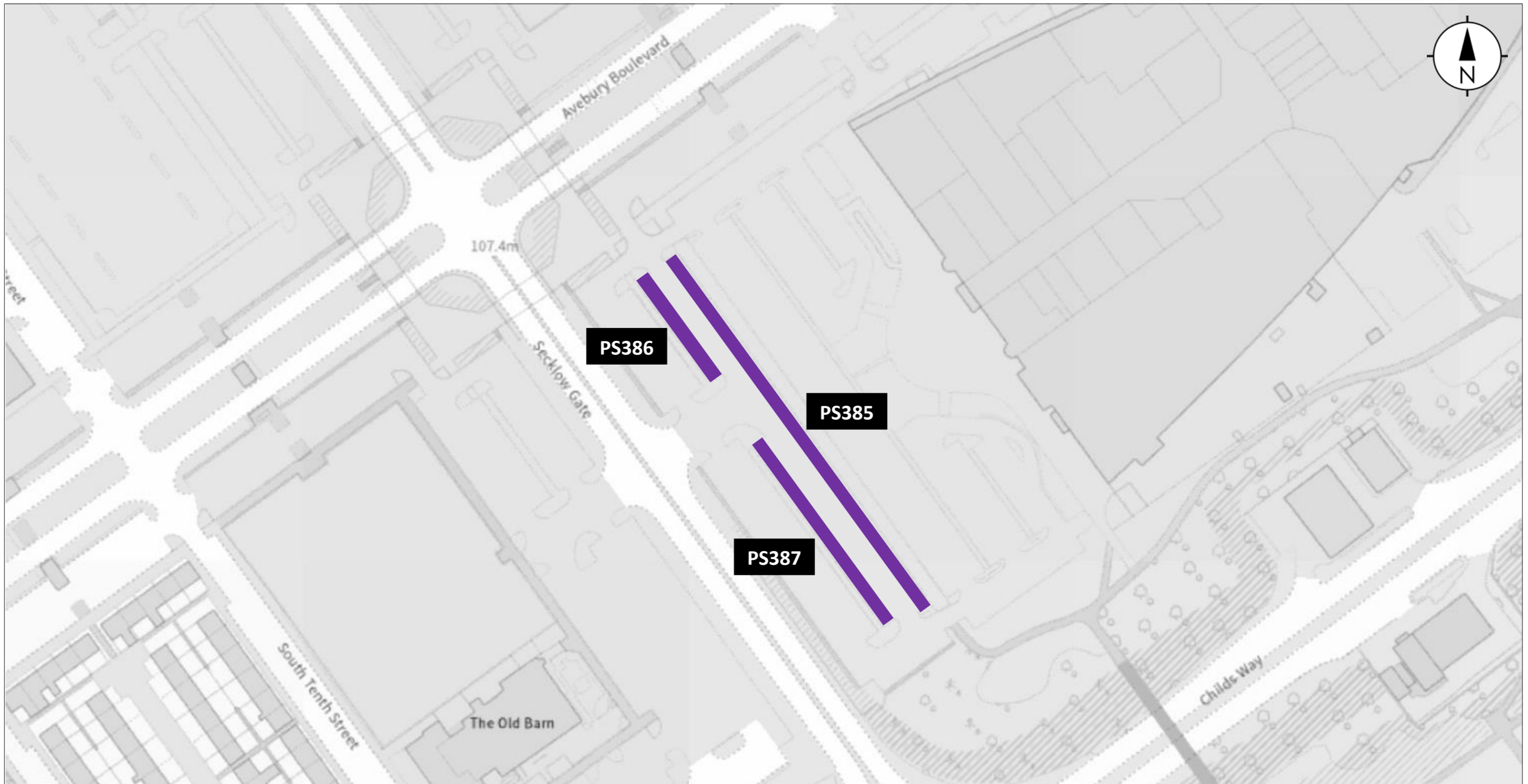
