Purpose	School grant funding available in 2025/26		

PE & Sport Premium

The Department for Education (DfE) have confirmed the details of the PE & Sports Grant for 2024/25 to give more children access to high quality PE lessons and sporting opportunities.

Allocations for the academic year 2024/25 were calculated using the number of pupils in years 1 to 6, as recorded in the January 2024 census, as follows:

- schools with 17 or more pupils receive £16,000 plus £10 per pupil
- schools with 16 or fewer pupils receive £1,000 per pupil

The allocations will be paid to schools in November 2024 and May 2025.

The grant is allocated per academic year with the current funding being agreed until August 2024. Further announcements on this grant funding are expected in the Spring. More information can be found <u>here</u>.

Pupil Premium

The DfE has confirmed funding rates will increase by 2.39% in 2025/26 compared to 2024/25 rates.

Universal Infant Free School Meals

The government have confirmed that the universal infant free school meals grant will continue during the 2024/25 academic year and the rate will increase to £2.58 (£2.53 for the 2023/24 academic year) per meal. The final allocations and grant conditions for the 2024/25 academic year can be found <u>here</u>.

Teachers' Pay Additional Grant (TPAG)

The DfE announced in July 2023, £525 million in 2023 to 2024 to support schools with the September 2023 teachers' pay award, with a further £900 million in 2024 to 2025. The funding for some school types/phases has been rolled into the relevant funding block with others continuing to be paid as separate grant funding as follows:

Teachers' Pension Employer Contribution Grant (TPECG)

The DfE published the outcome of the valuation of the teachers' pension scheme, this confirmed the employer contribution rate would be increased by 5% to 28.6% from 1 April 2024. Support for the increase was given through the TPECG. Funding for some school types/phases has been rolled into the relevant funding block with others continuing to be paid as separate grant funding as follows:

Core School Budget Grant (CSBG)

The CSBG is providing almost £1.1 billion to support schools with their overall costs in the 2024 to 2025 financial year, in particular following confirmation of the 2024 teacher pay award.
